

TRREB Real Women Event Sweepstakes Contest Rules and Regulations

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.

This “TRREB Real Women Event Sweepstakes Contest” (“**Contest**”) is sponsored by the Toronto Regional Real Estate Board (“**TRREB**”). This Contest is governed by these official rules (“**Rules**”). By participating in this Contest, you agree to abide by these Rules, including all eligibility requirements, and understand that the results of the Contest, as determined by TRREB, are final and binding. Any questions, comments or complaints regarding the Contest must be directed to TRREB.

ELIGIBILITY

The Contest is open to individuals who both reside and have reached the age of majority in Ontario.

Entrants must not be full-time employees of TRREB. Entrants must have attended TRREB’s Real Women Virtual Event. TRREB has the right to verify the eligibility of each entrant.

CONTEST PERIOD

The Contest begins on October 7, 2021, at 10:00 a.m. EST and ends on October 28, 2021, at 11:59 p.m. EST (“**Contest Period**”). All entries (submissions) must be received on or before the times stated during the Contest Period. TRREB reserves the right to extend or shorten the Contest Period at its sole discretion.

HOW TO ENTER

No purchase is required. During the Contest Period, you can enter the Contest through <https://trreb.ca/index.php/about-treb/sweepstakes>.

Entries/Submissions: You may enter the Contest by **submitting your first name, last name and email address**.

Entrants must include their first and last name in their entry. Entrants will be contacted by TRREB via the email address provided.

Each TRREB Member may submit only one (1) entry into the draw.

SELECTION OF WINNERS

All eligible entries received during the Contest Period will be entered into the Contest draw. Five (5) entries will be randomly chosen at the end of the Contest Period.

The five (5) winners will be announced no later than November 11, 2021, at noon EST. Winners will be contacted by TRREB via the email address provided on their Contest submission. Each entrant is responsible for monitoring and ensuring that their email account (as submitted) is active and current. Winners will be notified by TRREB and must contact TRREB within five (5) days of receipt of that email notice to claim their prize.

In order to claim a prize, winners will be required to correctly answer a time-limited mathematical skill-testing question without assistance of any kind, whether mechanical or otherwise, to be administered and returned by email, and TRREB reserves the right to require the winners to sign and return a declaration of eligibility and release, in the format requested by the TRREB, within ten (10) days from the date of delivery thereof.

If a winner cannot be reached by email by TRREB within five (5) days, does not contact TRREB within five (5) days of TRREB's email to claim the prize, does not satisfy the preceding conditions, declines the prize, or if the prize is returned as undeliverable, such winner shall forfeit the prize and TRREB reserves the right to select another eligible entry.
